Vestrado 50% Loyalty Bonus – Terms & Conditions

1. Introduction

The **Vestrado 50% Loyalty Bonus** ("Bonus Program") is designed to enhance traders' capital by providing a **50% bonus on each deposit**. By participating in this program, clients agree to the following Terms & Conditions.

2. Eligibility

- The **50% Loyalty Bonus** is available to **selected Vestrado clients** with a verified trading account.
- The bonus applies to **existing clients** who meet the deposit requirements.
- The bonus will be **credited automatically** to bonus accounts upon deposits.
- This bonus is only applicable to clients residing in **Malaysia, Brunei, and Singapore**.
- To entitle this bonus, the client must meet the following requirements:
 - 1) Client's total overall nett must be above 200 USD; and
 - 2) The client must trade a total minimum of 3 lots.

3. Bonus Structure & Conditions

- **Bonus Percentage:** Clients receive **50% of their deposit amount** as a trading bonus.

- **Maximum Bonus Limit:** The total bonus amount a client can receive is **capped at \$100**.
- **Leverage:** The bonus account is subject to a **1:300 leverage**.
- **Bonus Expiry:** The bonus remains valid for **90 days** from the date it is credited.

4. Trading & Withdrawal Conditions

- The **50% Loyalty Bonus** is for **trading purposes only** and **cannot be withdrawn**.
- Clients **can withdraw profits** generated from trading with the bonus funds **at any time** without any required trading volume.
- If a client initiates **any withdrawal from the bonus trading account**, the **entire bonus amount will be immediately removed** from the trading account without exception.
- **Internal transfers between accounts are not allowed** for the bonus account.

5. Disqualification & Fraud Prevention

Vestrado reserves the right to **cancel the bonus** and **remove any profits** if:

- The client **attempts to manipulate the bonus system** by using multiple accounts.
- The client engages in **abusive trading practices**, including hedging between multiple bonus accounts.



The client **fails to comply with the Terms & Conditions** or **Vestrado's Client Service Agreement**.

6. General Terms & Conditions

- Vestrado reserves the right to **modify, suspend, or terminate** the Bonus Program at any time **without prior notice**.
- By participating in this Bonus Program, clients acknowledge and accept these **Terms & Conditions**.
- In case of any **disputes or discrepancies**, Vestrado's decision shall be **final and binding**.
- In case of **translation inconsistencies**, the **English version** of these Terms & Conditions shall prevail.
